This piece of clothes is a personal protection mean with a very simple design and classified to the **1st category**, intended to protect users against the effect of weather factors, except for extraordinary and extreme impacts.

### 1. USE

The size of clothes should be fit accordingly with consideration for comfort of wearing. Protecting clothes, if correctly fit, should enable unrestricted movements at work. Check the clothes by trying it on before you start your work. Protecting clothes should be appropriately selected to correspond to the character of jobs on a specific workplace.
